### SECTION 1 PURPOSE OF COMPLIANCE TEST

Tests were conducted on a MY2006 Corbeil School Bus, NHTSA No. C60902, in accordance with the specifications of the Office of Vehicle Safety Compliance (OVSC) Test Procedures TP-217-06 to determine compliance to the requirements of Federal Motor Vehicle Safety Standards (FMVSS) 217, "School Bus Emergency Exits and Window Retention and Release".

This program is sponsored by the National Highway Traffic Safety Administration (NHTSA), under Contract No. DTNH22-02-D-01057.






