Traffic Report for week of November 15, 2015

White Sands Missile Range Notification

Missouri/I-25

The New Mexico Department of Transportation (NMDOT) along with FNF Construction (Contractor) continues work along I-25 and the city roadway enhancements of Missouri Avenue and intersections of Triviz Drive and Don Roser Drive.

City intersections of Missouri Avenue/Don Roser Drive and Missouri Avenue/Triviz Drive will continue to have active construction. Missouri Avenue will continue to have intermittent lane restrictions in both east and west bound lanes.

Shoulder work on Don Roser between Missouri Avenue and Idaho Avenue has begun in the southbound lane. This work is now scheduled to be completed the week of the 16th. Don Roser Drive between Missouri Avenue and Fairway Drive will continue to be closed. A wall barrier must be constructed before the re-opening of this section.

I-25 North Bound traffic will see transition changes over the next few weeks being that the new paving has been completed. Expect lane restrictions on I-25 Southbound as Guardrail crews will complete their tie-in work and barrier wall is relocated between 8:00 am and 4:30pm.

The next Public Meeting will be Wednesday November 25, 2015 which will start promptly at 6:00 pm at the NMDOT Las Cruces Complex located at 750 N. Solano.

I-10/Union Bridge-University - Las Cruces

The New Mexico Department of Transportation (NMDOT) along with La Calerita Construction (Contractor) continues with work at the I-10/Ramp E Bridge and the I-10/Union Avenue Bridge in Las Cruces, New Mexico. I-10 westbound lanes will continue to be detoured through the eastbound passing lane. Speed restrictions remain in effect through the I-10 construction zone. Eastbound access to I-10 at Valley Drive and University Avenue is closed. Use Conway Avenue to access eastbound I-10. Please obey the traffic signs, watch out for construction turning trucks and construction workers; drive safely.

The next Public Meeting will be Tuesday, December 8, 2015 which will start promptly at 6:00 pm at the NMDOT Las Cruces Complex located at 750 N. Solano.

N. Main/US 70 - Las Cruces

The New Mexico Department of Transportation (NMDOT) along with G. Sandoval Construction (Contractor) is nearing completion with only minor work left to be done to include the following:

I-10 Exit 135 Interchange

The New Mexico Department of Transportation (NMDOT) along with MWI Inc.(Contractor) currently have traffic control placed on I-10 at exit 135 between mile marker 134.08 to 134.82, west of Las Cruces, New Mexico. On Monday, November 16th the contractor will close the eastbound on and off ramp, traffic will be detoured through I-10 exit 132. Eastbound on and off ramps will be reopened on Wednesday 18th and the contractor will continue working with should work in place.

I-25/Rincon (South of Hatch, NM)

The New Mexico Department of Transportation (NMDOT) along with MANS Construction (Contractor) currently have traffic control placed on I-25 between mile marker 35.619 to 39.0, south of Hatch, New Mexico. The Contractor has begun roadway rehabilitation by milling the existing roadway and resurfacing the interstate where motorists will encounter lane and speed reductions during working hours. The Contractor's schedule is Monday to Friday from 6:00 am until 6:00 pm, and may change as work progresses.

McNutt Road Closure -

The Texas Department of Transportation has closed McNutt Road at the Rio Grande in Anapra/Sunland Park until further notice due to the Loop 375 construction project. Please follow detour signs to Racetrack Drive then onto Doniphan Drive.

NM 478 Mesquite to Anthony, NM

The New Mexico Department of Transportation (NMDOT) with Paveover Inc. (Contractor) will be working on NM 478 with pilot vehicle and flagging operations. The work will consist of recycling the existing mat in order to aid in extending the longevity of the roadway. The Contractor will be working from mile markers 0 to 10.0. Traffic control operations will be Monday to Saturday from 7:00 am until 6:00 pm, and is expected to be complete by the mid-November, 2015.

I-25, T or C, NM – Bridge Repair

The New Mexico Department of Transportation (NMDOT) with Villalobos Construction (Contractor) is currently repairing bridges from mile markers 80.2 to 81.7 with lane closures each direction with barrels only. Please use caution.

I25 Mile Post 51-75

The New Mexico Department of Transportation and J-H Supply (Contractor) will begin grade work with post and cable barrier installation follow in the median. There will be moving lane closures on this project. Work is expected to last until end of March 2016. Please use caution in the area.

NM1 Mile Post 1 to 21.2, Exit 100 to Exit 115

The New Mexico Department of Transportation and G. Sandoval Construction (Contractor) will be performing repairs and erosion control on the CBC at mile post 21. The road will be closed at both Exit 100 and 115 to thru traffic. This work is expected until May 2016. Please use caution.

New Mexico 52/New Mexico 59 - Chip Seal

The New Mexico Department of Transportation (NMDOT) along with Blue Collar Construction (Contractor) will be working on NM 59 from mile markers 0.00 to 32.00 and New Mexico 52 from

mile markers 0.00 to 36.00, where motorist will encounter lane restrictions. Work will resume next Spring 2016. Please use caution as there is loose rock and slick roadway.

NM 90/Hudson Street Bridge – Silver City

The New Mexico Department of Transportation (NMDOT) along with Interstate Highway Construction (IHC) (Contractor) has CLOSED all access over the NM 90/Hudson Street Bridge. The NMDOT and IHC continue with the construction of the bridge overpass. The contractor has installed various notifications alerting motorists of the closures. In addition, the NMDOT will have traffic control advising motorists that the county Truck Bypass route will be available. The San Vicente Trail will be closed at Corbin Street along with South Mill Road, and under the bridge.

The next Public Involvement Meeting is scheduled for 6:00 pm on Wednesday November 18, 2015 at the Grant County Administration Building, 1400 Hwy. 180 E, Silver City, NM 88061. The meeting will start promptly at 6:00 pm with members of the NMDOT and IHC will be available to answer any questions the public may have regarding the project.

US 180 East, Silver City – Mill & Inlay

New Mexico Department of Transportation (NMDOT) along with Mountain States Construction (Contractor) has completed this project except for the third application of striping, which will take place on November 17th.

I-10 Lordsburg – Mile Post 26.73

The New Mexico Department of Transportation (NMDOT) along with Hasse Contracting (Contractor) will be performing bridge repair work at mile marker 26.73 in the west bound lane; east bound lane will encounter a one lane closure. Traffic will be switched over to the east bound lane on November 9th.

NM 27 – Mile Post 25.40

The New Mexico Department of Transportation (NMDOT) along with Kimo Construction (Contractor) will be performing bridge repair work at mile marker 25.40. Work is scheduled to begin on November 16th with project signing being installed.

I-10 Lordsburg – Mile Post 29

The New Mexico Department of Transportation (NMDOT) along with James Hamilton Construction (Contractor) will be performing bridge repair work and partial reconstruction of the roadway at mile marker 29 beginning Tuesday, September 29th. Detour signs are installed for traffic, which is utilizing the detour in the west bound lane.

Bridge Repair - Various Locations on I-10/I-25

The New Mexico Department of Transportation (NMDOT) along with Hasse Contracting Inc. (Contractor) will be working on repairing various bridges in District One, along the I-10 & I-25 corridors. The Contractor will currently be working over I-10 near milepost 85 (Exit 85 Bridge over I-10). I-10 Westbound on-ramp at this location will be CLOSED to traffic. Motorists wanting to enter I-10 West are being directed to use on-ramps off of either N. Gold Avenue or W. Pine Street; detour signing will also be in place. I-10 West motorists using Exit 85 are advised to use caution as a single lane closure will be in effect with reduced speeds over the bridge with the possibility of overnight lane closures as well. Work in this area is expected to continue through the end of November 2015. I-10 one lane closures may be in place to distance vehicles from the potential of falling debris during construction.

Las Cruces – I-25/Lohman Sidewalk

The New Mexico Department of Transportation (NMDOT) will be conducting a sidewalk upgrade on the southeast corner of Lohman and I-25. Work should begin Monday, November 16 thru November 20; hours of operation are from 9:00 a.m. to 3:00 p.m. The right lane will be closed on Lohman Avenue traveling east over the bridge as well as the sidewalk. All sidewalk traffic will need to use crossover on north side of bridge. Traffic may then merge after work zone, which is approx. 100 feet in length.

Las Cruces Projects – City of Las Cruces

Crescent Drive

From Apollo Drive to Farney Lane will be closed to through traffic. Access to residents will be maintained at all times. Motorists will be asked to decrease speed through the construction zone and should proceed with caution.

Don Roser

From University Avenue to Terrace Drive will have intermittent lane closures. Access to residents and businesses will be maintained at all times. Motorists will be asked to decrease speed through the construction zone and should proceed with caution.

Jill Circle

From O'Hair Drive to cul-de-sac will be closed to through traffic. Access to residents will be maintained at all times. Motorists will be asked to decrease speed through the construction zone and should proceed with caution.

Macaw Circle

From O'Hair Drive to cul-de-sac will be closed to through traffic. Access to residents will be maintained at all times. Motorists will be asked to decrease speed through the construction zone and should proceed with caution.

Mary Circle

From Salopek Blvd to cul-de-sac will be closed to through traffic. Access to residents will be maintained at all times. Motorists will be asked to decrease speed through the construction zone and should proceed with caution.

O'Hair Drive

From Salopek Blvd to Oleta Drive will be closed to through traffic. Access to residents will be maintained at all times. Motorists will be asked to decrease speed through the construction zone and should proceed with caution.

Salopek Blvd

From Stern Drive to Oleta Drive will be closed to through traffic. Access to residents will be maintained at all times. Motorists will be asked to decrease speed through the construction zone and should proceed with caution.

Sixth Street

From Wilson Avenue to Dead End North will be closed to through traffic. Access to residents will be maintained at all times. Motorists will be asked to decrease speed through the construction zone and should proceed with caution.

Telshor Blvd

From Spruce Avenue to 500 feet south of Summit Court will have a lane closures in the northbound direction. Access to residents and businesses will be maintained at all times. Motorists will be asked to decrease speed through the construction zone and should proceed with caution.
