The article says that new legislation would allow police officers to use an oral swab test to test for the presence of various illegal drugs as well as pain medications, although, according to Dale Gieringer, director of the California branch of the National Organization for the Reform of Marijuana Laws, this type of testing has not yet been proven effective to determine whether a driver is indeed impaired.
