The rally has become known for the past eight years as not only a premier automotive event but also an internationally celebrated one for its prominent attendees and significant fundraising. Those organizations who have benefitted include the Wounded Warrior Project, various children's cancer charities, and the Taylor Lynn Foundation, which teams with the rally to provide microgrants that give children in need the ability to participate in activities that they could not participate in otherwise.
