He said the guide provides information on how to take legal action against trucking companies, manufacturers of big-rigs, shipping companies, leasing companies and brokers or agents.

“You might think it's just the fault of that individual trucker who made a mistake, but a lot of times there's a deeper story that goes back and it's actually the trucking company that has done something wrong that has led up to that moment when somebody is injured,” said John Cooper.
