Interstate:

I-40 westbound at 98th street; shoulder closure at off-ramp:

I-40 westbound at 12 street:

Through August 11^{th} , 2017; from 9 P.M. to 5 A.M. various lane restrictions nightly on I-40 westbound at 12^{th} street bridge for maintenance work.
