

NMDOT District 3-Albuquerque Roadwork Advisory Report – December 28th, 2017 through January 4th, 2018

Interstate:

I-40 eastbound Project A300078R: (No Lane Restrictions starting at 3 PM Friday 12/29/2017 through Monday 1/1/2018)

Through January 12th, 2018; Monday through Friday from 9 A.M. to 5:30 A.M the following day I-40 eastbound will have various and shoulder restrictions in place for concrete repair between NM 45 (Coors Blvd) and Rio Grande Blvd. Also NM 45 (Coors Blvd) northbound and southbound on ramps to I-40 eastbound will have intermittent lane restrictions. Contractor: Structures Inc.

I-25 northbound & southbound at Exit 230 (San Mateo Blvd) Project A301181: (Jefferson On-Ramp to I-25 SB will be closed 9 AM to 3 PM Friday 12/29/2017 & Tuesday 1/2/2018)

Through May 31st, 2018 I-25 NB & SB at Exit 230 (San Mateo Blvd) will have various shoulder and lane restrictions throughout the duration of the project. I-25 southbound off ramp to San Mateo Blvd will be closed until further notice. Detours will be provided along I-25 southbound alerting motorists to exit at San Antonio.

San Mateo Blvd / Osuna Rd will have various lane and shoulder restrictions throughout the duration of the project.

ALERT---NM 45 northbound & southbound between Irving Blvd and Ellison Dr:
