

NMDOT District 3-Albuquerque Roadwork Advisory Report – January 11th, 2018 through January 18th, 2018

Interstate:

I-40 eastbound & westbound Project A300078R:

Through January 19th, 2018; Monday through Friday from 9 A.M. to 5:30 A.M the following day I-40 eastbound will have various lane and shoulder restrictions in place for concrete repair between NM 45 (Coors Blvd) and Rio Grande Blvd. Also NM 45 (Coors Blvd) northbound and southbound on ramps to I-40 eastbound will have intermittent lane restrictions.

Early start January 9th, 2018 through February 2nd, 2018; Monday through Friday from 8 P.M. to 3 P.M the following day I-40 westbound will have right lane and shoulder restrictions in place for concrete repair between The BIG-I (milepost 159.5) and 12th Street (milepost 157.5). Also I-25 southbound to I-40 westbound flyover ramp will have a right lane restriction.

I-40 eastbound & westbound milepost 140.4 to 132 Project 9900707:

January 18th through March 18th, 2018; Monday through Friday from 8 A.M. to 3 P.M the I-40 eastbound will have left lane and shoulder restrictions, and I-40 westbound will have shoulder restrictions in place for utility install between milepost 140.4 and 132.

I-25 southbound at milepost 254.5:

January 15th through January 19th, 2018 I-25 SB at milepost 254.5 near San Felipe Pueblo will have left lane and shoulder restrictions for guardrail repair

I-25 northbound & southbound at Exit 230 (San Mateo Blvd) Project A301181:

Through May 31st, 2018 I-25 NB & SB at Exit 230 (San Mateo Blvd) will have various shoulder and lane restrictions throughout the duration of the project. I-25 southbound off ramp to San Mateo Blvd will be closed until further notice. Detours will be provided along I-25 southbound alerting motorists to exit at San Antonio.

San Mateo Blvd / Osuna Rd will have various lane and shoulder restrictions throughout the duration of the project.
