



## **NMDOT District 3-Albuquerque**

**Roadwork Advisory Report – November 16<sup>th</sup>, 2017 through November 24<sup>th</sup>, 2017**

### **Interstate:**

#### **I-40 eastbound Project A300078R:**

Through January 2<sup>nd</sup>, 2018; Monday through Friday I-40 eastbound from 9 A.M. to 5:30 A.M. the following day will have continuous right lane and shoulder restrictions in place for concrete repair between NM 45 (Coors Blvd) and Rio Grande Blvd. Also NM 45(Coors Blvd) northbound and southbound on ramps to I-40 eastbound will have lane restrictions.

#### **I-40 westbound & eastbound off ramps at Exit 230 (San Mateo Blvd):**

Through November 22<sup>nd</sup> I-40 eastbound and westbound Off Ramps to San Mateo will have continuous restrictions to the left and or right turn bays. These restrictions are associated with work taking place on San Mateo for utility repair.

#### **I-40 eastbound off ramps at Exit 230 (4<sup>th</sup> Street):**

Through November 22<sup>nd</sup> I-40 eastbound Off Ramps to 4th Street will have continuous left lane restrictions. These restrictions are associated with utility repair work.

#### **I-25 northbound & southbound at Exit 230 (San Mateo Blvd) Project A301181:**

Through May 31st, 2018 I-25 NB & SB at Exit 230 (San Mateo Blvd) will have various shoulder and lane restrictions throughout the duration of the project.

I-25 southbound off ramp to San Mateo Blvd will be closed as of November 13th, 2017. Detours will be provided along I-25 southbound alerting motorists to exit at San Antonio or Jefferson.

San Mateo Blvd / Osuna Rd will have various lane and shoulder restrictions throughout the duration of the project.

#### **I-25 at NM 500 (Rio Bravo) Interchange Project A300280:**

Through summer of 2019; there will be continuous lane and shoulder closures /restrictions of NM 500 (Rio Bravo) and I-25 northbound and southbound. Work is being performed to facility a new NM 500 (Rio Bravo) Interchange with I-25.
