"After our first practice was rained out, we finally got on track and suspected right away we had trouble with the motor," MÃ¼nter explained. "We tried some different gears, but just couldn't get it to turn the RPMs we needed. After qualifying, we pulled the filter and found debris. We believe we have a problem in the valve train and we don't want to risk blowing the motor and causing a wreck out there for the guys who are running for the championship. We're highly disappointed but we feel this is the best decision. I had a great run in Texas and I was really looking forward to racing again. Obviously I am heartbroken.
