The lawsuit alleges M & M Automotive Group, Inc. violated the California Labor Code by failing to provide compliant meal and rest breaks.

SAN FRANCISCO ([PRWEB](#)) March 01, 2021 -- The San Francisco employment law attorneys, at [Zakay Law Group, APLC](#) and [JCL Law Firm, APC](#), filed a lawsuit alleging that M & M Automotive Group, Inc. violated the California Labor Code. The M & M Automotive Group, Inc. lawsuit, Case No. HG21086853, is currently pending in the Alameda County Superior Court of the State of California. A copy of the Complaint can be [read here](#).

The lawsuit alleges M & M Automotive Group, Inc. violated the Private Attorneys General Act (“PAGA”), which gives rise to civil penalties as a result of M & M Automotive Group, Inc.'s conduct. PAGA allows aggrieved employees to step into the shoes of California state regulators to recover civil penalties, which means ordinary citizens are “deputized” as private attorneys general to enforce the Labor Code. [PAGA](#) authorizes aggrieved employees to file a lawsuit to recover civil penalties on behalf of themselves, other employees, and the State of California for Labor Code violations.

Cal. Lab. Code § 226 provides that every employer shall furnish each of his or her employees with an accurate itemized wage statement in writing showing, among other things, gross wages earned and all applicable hourly rates in effect during the pay period and the corresponding amount of time worked at each hourly rate. M & M Automotive Group, Inc. failed to issue to its employees an itemized wage statement that lists all the requirements under [Cal. Lab. Code § 226](#). As a result, from time to time, M & M Automotive Group, Inc. provided its employees with wage statements which the California Labor Code.
