The token is issued via Blockstream AMP, a platform for the tokenization of securities built on the Liquid sidechain of Bitcoin, which has been directly integrated with STOKR.

"We are excited to work with Mazzanti and empower both private and professional investors to actively take part in the firm's growth by acquiring a share in its future revenue via our innovative fundraising vehicle."

With more than 20 years of successful operations under its belt, Mazzanti is renowned for its unique "one-off" luxury cars, which are tailor-made and sold to collectors around the world. Its Millecavalli series of highquality hand-crafted race cars has been widely acclaimed across the automobile industry.
