### **Roadwork Advisory Report – March 8<sup>th</sup>, 2018 through March 15<sup>th</sup>, 2018**

#### **Interstate:**

##### **I-40 westbound Project A300078R:**

Through March 16<sup>th</sup>, 2018; Sunday through Friday from 8 P.M. to 3 P.M. the following day I-40 westbound will have daily left lane and shoulder restrictions in place for concrete repair between The BIG-I (milepost 159.5) and 12<sup>th</sup> Street (milepost 157.5).

##### **I-40 westbound Project A300079:**

Through May 5<sup>th</sup> Phase 1 improvements to the I-40 westbound on and off ramps at the Louisiana Interchange and Louisiana Boulevard shall commence. This phase includes night work from 9pm to 5am with various lane closures for compact grout injection. During this phase there will be no full closures of the on or off ramps to Louisiana from I-40. Expect delays

#### **I-25 northbound & southbound at Exit 230 (San Mateo Blvd) Project A301181:**
