The General Accounting Office has made limited inquiries into the utilization of Government-owned passenger motor vehicles assigned to the United States Army, Ryukyu Islands (USARYIS), and the United States Civil Administration of the Ryukyu Islands (USCAR). We found, based on our limited survey of the practices of both these organizations, that there was considerable evidence of unofficial use of passenger vehicles. We also found that the vast majority of assigned vehicles were being placed at the disposal of the same individuals daily rather than being assigned to a motor pool.

Both law and regulation generally prohibit the use of United States owned vehicles for personal use such as home-to-work transportation. In this regard, 31 U.S.C. 638a(c)(2) states in part:

"Unless otherwise specifically provided, no appropriation for any department shall be expended--for the maintenance, operation, and repair of any Government-owned passenger motor vehicle or aircraft not used exclusively for official purposes; and 'official purposes' shall not include the transportation of officers and employees between their domiciles and places of employment, except in cases of medical officers on out-patient medical service and except in cases of officers and employees engaged in field work the character of whose duties make such transportation necessary and then only as to such latter cases when the same is approved by the head of the department concerned ***"

At USARYIS we found that, while an exception had been obtained to provide home-to-work and return transportation for the Commanding General, at least six other sedans were being used regularly for transporting other officials for the same purpose. In addition, more than 65 trips of an apparently personal nature had been made during a recent one-week period. These trips included visits to such places as the golf course, gift shops, Yaka Beach, snack bars, and officer and civilian clubs.

At USCAR, our survey disclosed that, while an exception had been obtained to provide home-to-work and return transportation for the Civil Administrator, at least four other sedans were being used regularly for transporting other officials for the same purpose. Also, we found that about 50 unofficial trips had been made in addition to the regular use of official vehicles for home-to-work transportation during a recent two-week period. These trips included visits to such places as the PX, the golf course, gift shops, and officer and enlisted clubs.

We advised the Commanding General, USARYIS, and the Civil Administrator, USCAR, of our findings. We recommended that USCAR and USARYIS conduct a more detailed examination to determine the extent of unofficial use of passenger vehicles and to develop procedures to minimize such unauthorized use. In this connection, we suggested that motor pools might be utilized to the maximum extent possible. We have been advised by USCAR and USARYIS officials that corrective measures have been taken to preclude unofficial use of Government vehicles and that maximum use is now being made of motor pools.

We are bringing this matter to your attention so that appropriate measures can be taken to preclude the possibility of this occurring at other locations. You may wish to advise the Army Audit Agency, Inspector General, and other management review staffs in the Pacific theater to consider this matter in their reviews.

We are planning no additional work in this area at this time but would appreciate being advised of any corrective measures taken or planned with respect to the matters discussed in this letter.
