- (c)(3) Total number of vehicles potentially affected: Estimated at 301
- (c)(4) Percentage of vehicles estimated to contain the defect: Unknown
- (c)(5) Description of the defect: Business Class M2 106V incomplete chassis cab vehicles may have headlights which measure greater than 54" from the road surface. Federal Motor Vehicle Safety Standard 49CFR571.108(§5.3) requires headlights to be not less than 22 inches, nor more than 54 inches above road surface.

49CFR Section 577.5(f) Evaluation of the risk to motor vehicle safety: Improper height of headlights may not fully illuminate road surface or may inhibit the ability of motorists to see vehicles. This can increase the risk of traffic accidents.

(c)(6) Chronology of principal events:

- (c)(7) Noncompliance-test or other data: At the end of June 2010, a DTNA manufacturing plant noted that some incomplete chassis cabs had headlamps measuring approximately 0.5" above 54". On July 16th, 2010, DTNA initiated recall FL-583 to address the incomplete chassis cabs and put in place procedures to identify and hold affected incomplete chassis cabs. The procedure included calculating the height of the headlamps on various chassis cab configurations to identify any that may be above 54". Chassis cabs identified as such were to be held from release to end customers. Chassis cabs measuring at or below 54" after the installation of body equipment were to be released. In March 2011, DTNA determined that the procedures put in place July 2010 were not fully effective in ensuring that no chassis cabs had non-compliant headlamps after completion with body equipment installation.
- (c)(8) (i) Remedial program: Vehicle headlamp height will be inspected. Any vehicles with headlamps above 54" will receive new headlamps that lower the bulb center to be at or below 54". Repairs will be performed by Daimler Trucks North America authorized service facilities.
 Reimbursement Plan: Copies will be submitted as a supplemental report when available.

(ii) Estimated Owner and Dealer Notification Date: Customer notification will be by first class mail using Daimler Trucks North America records to determine the customers affected. This will be completed approximately May 25, 2011.

Dealer and distributor notification will be completed approximately May 25, 2011.
