The Debris Free Hiways' Pilot Program begins on July 1, 2004 in South Florida. We will cover the 177.2 miles (both Northbound and Southbound Lanes) of Interstate 95 from the Palm Beach County / Martin County Line to the end at US1 (Coral Gables). We will also cover the 235.8 miles of the Florida Turnpike from the Palm Beach County / Martin County Line (both Northbound and Southbound Lanes) to Florida City / Homestead in South Miami-Dade County.

([PRWEB](#)) May 20, 2004 -- The concept of Debris Free Hiways came about, in part, due to the ever rising and alarming rate at which motorists are being killed or seriously injured on the Interstate and Turnpike by road debris. A day rarely goes by that we don't read about this problem in the newspaper or watch it on the news. Businesses and organizations in the Tri-County area , through their sponsorship, can now take an active role to greatly reduce the fatality and injury rate caused by road debris.

Our Pilot Program begins on July 1, 2004 in South Florida. one to notify an employer, family member, or friend and one to call for assistance from a tow truck, AAA, a car dealership, a motorcycle dealership for towing to a repair facility. We will have a list of available options and telephone numbers depending on the motorist's location.
