**[Regarding Choice-of-Law for Certain Plaintiffs]**

On December 19, 2014, the Court ordered General Motors LLC (“New GM”) and Plaintiffs, through Lead Counsel (collectively, the “Parties”), to submit briefs with respect to choice of law issues relating solely to claims brought by Plaintiffs in the Consolidated Complaint Concerning All GM-Branded Vehicles That Were Acquired July 11, 2009 Or Later (the “Complaint”) (Doc. No. 345) who “allege vehicles that were definitely manufactured by New GM.” (See Order No. 30, Doc. No. 478).

As agreed by the Parties (Doc. No. 487), there are 22 Plaintiffs who allege vehicles that were manufactured by New GM. These 22 Plaintiffs are from 14 different jurisdictions:

On February 20, 2015, the Parties each submitted opening briefs concerning choice of law issues. (Doc. No. 597 (New GM's brief); Doc. No. 598 (Plaintiffs' brief)). The Parties do not agree with each other's characterizations of the variation, or lack of variation, in the law; however, the Parties have met and conferred over the immediate issue before this Court and stipulate and agree to the relief in this Order.

In accord with the Parties' stipulation and agreement, the Court orders that, with respect to all of the claims of each of the above-named 22 Plaintiffs who allege vehicles that were manufactured by New GM, the substantive laws of each Plaintiff's home jurisdiction will govern all of that Plaintiff's claims asserted in the Complaint.
