COMPLAINANT'S MOTION TO COMPEL RESPONDENT TO COMMUNICATE

This motion is predicated on the urgent need for effective and directive communication, crucial for the orderly progression of the ongoing proceedings.

Statement of the Motion:

The Complainant hereby moves the Commission to compel the Respondent to communicate directly and exclusively with the Complainant's designated email address: ageneral.manager@uslautoexporting.com, and to cease all communication to email address (arwini.khalid@gmail.com). This request is supported by the enclosed email correspondence, which includes copies to the honorable Judges.

Grounds for the Motion:

1. Non-Compliance with Preferred Communication Channel: Respondent has continued to send emails to an outdated email address (arwini.khalid@gmail.com), despite being

informed of the official communication channel (ageneral.manager@uslautoexporting.com). This practice hinders effective communication and disregards the Complainant's specified preference.

- 2. Adherence to Commission's Directive: Commission has directed both parties to collaborate on a joint status report within the next 15 days. Proper adherence to this directive is only feasible through communication to the designated representative email of the Complainant.
- 3. Upcoming Preliminary Conference: The upcoming preliminary conference with the Commission's Office of Consumer Affairs and Dispute Resolution Services (CADRS) necessitates clear and directed communication. The Respondent's current practice of sending emails to an unauthorized address could lead to miscommunication and procedural delays.

Conclusion: In light of the above, the Complainant respectfully requests the Commission to enforce this Motion to Compel, thereby mandating the Respondent to adhere to the specified communication protocol. This measure is critical to ensure transparency, efficiency, and compliance with the Commission's directives, thereby facilitating a fair and orderly progression of the case.
