These refrigerators were put into a select few units – all have been identified.

Norcold stated that certain refrigerators contain either a sensing algorithm or a thermal switch to interrupt power to the refrigerator when it detects high temperatures that could lead to a fire.

The remedy is to affix a thermocouple, with a faster response time, to all refrigerators equipped with a sensing algorithm or a thermal switch.

Sierra Custom Interiors has discontinued use of this product.

We have not installed one of these units after 11/1/2008 – we currently have one more unit in stock and will be returning it to the manufacture for credit or to be fitted with correct thermocouple.
